We splurged on a paid website, so we can collect payments for tickets and sponsorships. www.terrorforacause.com The money just sits online until we get a bank account. Can we set up a Square account and link that? Katie will look into it.

Haunted House is at the fairgrounds, we will get a key in the middle of August to start work. We don't need to sign any paperwork or do background checks - just put down monthly deposit each month.

Any volunteers that we don't know personally, we should think about doing background checks to make sure we are creating a safe environment. Sterling Volunteers - Cost per background check - basic is \$20, more extensive is \$40. If they just did a background check in the last year, we can use that and it's free.

Can we use smells in the haunted house this year?

Dates: Friday/Saturday of October, except for Saturday before <u>Halloween</u>. We will advertise that date as sold out. And November 1st. Tear down November 2 through 8. No restrictions on times.

VIP night on Thursday, October 2nd at 7:00pm. Put when sunset is and when blackout should be on ticket so people know when it will be spookiest?

Lights up to the haunted house for foot traffic - does the fairground have street lights?. See if we have heaters for outside - can find a few more on buy nothing

Insurance - make sure we have all of the dates correct and all of the details before we finalize it. \$1,500-ish includes setup month and actual month. No moving floors, no hanging nooses, no

touching, no interacting. Lots of signs posted up front. We can have the final list of to-do's when we finalize the insurance. Guests will still need to sign a waiver before entering.
